He expressed his wish to continue use of the Township Hall for Homeowner's Association meetings.

Dunleavy moved to wait until the Township attorney drafts and reviews a proposal for use of the Township Hall for future uses. Huff supported the motion.

Chemung Hills Golf Course

Dunleavy moved to move \$250,000.00 (two hundred fifty thousand dollars) from Building and Site to the Chemung account for ongoing renovations at Chemung Hills Golf Course. Philibeck supported the motion.

Dunleavy moved to approve the payment of \$52,334.20 (fifty-two thousand three hundred thirty-four dollars and twenty cents) to Richland Construction, \$5,599.84 (five thousand five hundred ninety-nine dollars and eighty-four cents) to Best Buy for the purchase of new TVs and mounts for the grill area, \$2070.00 (two thousand seventy dollars) for the reupholstering of nine benches by Kathi's Upholstery for a total amount of \$60,004.04 (sixty thousand four dollars and four cents).
