Property Tax Millage Rate Proposed to be Levied to Support the General Fund Henshaw moved to comply with the General Appropriations Act (MCL 141.437) by adopting the tax levy Fiscal Year 2023/2024 of .6491 mills per \$1,000.00 (one thousand dollars) of taxable value for the Operating Millage for the General Fund. This levy will generate \$509,923.00 (five hundred nine thousand one hundred twenty-three dollars) which is \$35,122.00 (thirty-five thousand one hundred twenty-two dollars) more than the amount levied for 2022-2023 taxes.
